## UPCOMING ENVIRONMENT COUNCIL - ENVIRONMENT MINISTERS INVITED TO IDENTIFY GAPS IN CIRCULAR ECONOMY LEGISLATION

Ahead of the Environment Council scheduled on <u>27 March</u>, Member states will discuss, among others, the challenges in advancing a circular economy, including potential legislative gaps in scaling up reuse, remanufacturing, and recycling. Ahead of the meeting the Council released two policy notes to guide discussions.

- <u>Policy note on environmental dimension of the Clean Industrial Deal</u>, aiming to drive industrial growth through decarbonisation while integrating key economic and trade policies.
- <u>Policy note on Global environmental policies</u>: highlights the continuation of global plastics treaty negotiations at the fifth session of the Intergovernmental Negotiating Committee in August.

# PACKAGING AND PACKAGING WASTE – EXEMPTIONS FROM THE REUSE OBLIGATIONS FOR PLASTIC WRAPPINGS AND STRAPS (DELEGATED ACT)

# JRC FACTUAL SUMMARY REPORT OF TARGETED STAKEHOLDER CONSULTATION ON EU HARMONISED WASTE SORTING LABELS AS PART OF THE PPWR

As the European Union (EU) continues to deal with the increasing quantities of packaging waste and its environmental impact, one area of focus is the harmonisation of waste sorting labels across EU Member States. This effort aims to for easier and more accurate packaging waste sorting in the EU.

In this context, between 2 September and 30 September 2024, the European Commission Joint Research Centre (JRC) invited stakeholders to a targeted consultation to gather insights on key aspects of the waste sorting labels currently being developed. The consultation concerned the design and implementation of material-based waste sorting labels as part of the Packaging and Packaging Waste Regulation (PPWR). These labels will be applied to packaging and waste receptacles, providing clear guidance on proper disposal to people in the EU. #### REVISION OF WASTE FRAMEWORK DIRECTIVE VALIDATED BY MEPS AND COUNCIL

On March 18, members of the European Parliament's Envi Committee <u>approved the agreement reached</u> <u>during the trilogues</u> held at the end of February. The following day, the ambassadors (Coreper 1) of the Twenty-Seven also supported the compromise, which must now be approved in the plenary and by ministers in the coming weeks. While the Commission's initial proposal, focused on harmonizing the extended producer responsibility (EPR) scheme in the textile sector, did not address the "fast fashion" model, the co-legislators decided otherwise. Member States will be able to adapt the EPR contribution based on the durability and longevity of products. The agreement also contains numerous review clauses, including those to assess the possibility of establishing prevention, collection, reuse, and recycling targets for textiles. As the directive requires, capitals will have to transpose it.

#### EC PROPOSES TO CUT RED TAPE AND SIMPLIFY BUSINESS ENVIRONMENT

The European Commission has adopted new proposals that will cut red tape and simplify EU rules for citizens and business.

- Simplifying EU rules and boosting competitiveness Omnibus I
- InvestEU European Union Omnibus II
- Questions and Answers Omnibus package

Collectively, with these measures, the Commission wants to reduce administrative burdens by 25%, and by 35% for small and medium-sized businesses, by the end of its mandate in 2029.

# EUROPEAN PARLIAMENT: EPP WANTS TO ADOPT OMNIBUS ON REPORTING OBLIGATIONS QUICKLY

The omnibus package aimed at amending the Directives on Due Diligence (CS3D) and Non-Financial Reporting (CSRD) consists of two proposals. This will result in a two-year postponement of the initial obligations under the CSRD (2027 instead of 2025) and a 1 year postponement of the transposition of the CS3D (July 2027 instead of July 2026).

- In Parliament, the EPP wants to keep pace with this and submitted a request on March 13 to trigger the emergency procedure provided for in Rule 170 of the Parliament's Rules of Procedure. MEPs will have to decide whether to use this procedure **in plenary on April 1**.
- If approved, President Metsola will be able to set debate and voting on the directive.
- On March 19, the EPP appointed Swedish MEP Jörgen Warborn as rapporteur. Several committees will issue opinions, namely the Environment, Employment, Economic Affairs, International Trade, and Foreign Affairs committees.

#### EUROPEAN LEADERS WANT FASTER SIMPLIFICATION DRIVE

EU heads of state and government will discuss simplification and cutting red tape at a <u>European Council</u> <u>meeting</u> in Brussels. While they back the Commission's simplification drive — as embodied in the first omnibus simplification package presented last month — they want the EU to go even faster, according to the latest draft <u>Council Conclusions</u>;

Meanwhile, the European Parliament will be voting on whether to apply the urgent procedure to fast track the adoption of the Commission's proposal to "stop the clock" on the implementation of the corporate sustainability reporting, due diligence and taxonomy rules <u>on April 1</u>.

#### FCM - THE EU INTRODUCED STRICTER PURITY AND MIGRATION LIMITS FOR PLASTIC FOOD CONTACT MATERIALS UNDER REGULATION (EU) 2025/351

On February 24, 2025, the European Union released <u>Commission Regulation (EU) 2025/351</u>, amending existing laws related to food contact plastics and recycled plastic materials. This new regulation, which will come into effect on March 16, 2025, revokes the outdated recycled plastic regulation (EC) No 282/2008 and introduces several critical updates aimed at improving safety and sustainability in the industry. The Regulation bringing significant changes to the manufacturing and use of plastic food contact materials across the European Union. Effective 24 March 2025, the amendments introduce stricter purity requirements, migration limits, and labelling obligations for both virgin and recycled plastics. Businesses have until 16 September 2026 to ensure full compliance or risk market restrictions.

#### EUROPEAN PARLIAMENT PLENARY ROUND-UP – MARCH 2025

The future of European Union defence unsurprisingly topped the <u>March 2025 plenary session agenda</u>. Debates looked also at the Commission's vision for agriculture and food, and the first 'omnibus' simplification proposals, as well as on supporting EU regions vulnerable to the effects of climate change; the social and employment aspects of restructuring processes.

#### COMMISSION RESPONDS TO UNJUSTIFIED US STEEL AND ALUMINIUM TARIFFS WITH COUNTERMEASURES

In response to the imposition of new, unjustified US tariffs on EU steel and aluminium imports, the Commission has launched swift and proportionate countermeasures on US imports into the EU. The Commission's response is carefully calibrated, based on a two-step approach:

- First, the Commission will allow the <u>suspension of existing 2018 and 2020</u> <u>countermeasures</u> against the US to lapse on 1 April. These countermeasures target a range of US products that respond to the economic harm done on €8 billion of EU steel and aluminium exports.
- Second, in response to new US tariffs affecting more than €18 billion of EU exports, the Commission is putting forward a package of new countermeasures on US exports. They will come into force by mid-April, following consultation of Member States and stakeholders.

#### FOREST AND FORESTRY STAKEHOLDER PLATFORM (9 APRIL 2025)

The agenda concerns an introduction from the Commission followed by questions or input from members on Bioeconomy, an input from members on the CAP, an update from the Commission followed by possible questions or input from members on the Nature Restoration Regulation (TBC) and on Biodiversity certification and nature credits (TBC), as well as information and possible follow up from the Commission on the webinar on Closer to Nature Forest Management certification of 14 March 2025, information from the Commission on the Workshop on the implementation of the European Commission's Forest guidelines in the Boreal Region and the Circular Bio-based Europe Joint Undertaking (CBE JU) call for proposal 2025 and previous and ongoing projects on forest and forestry.

#### PLASTICS RECYCLERS IN CRISIS

Europe's plastic recycling sectors have put out a call for help as more and more recycling centers are force to close down. The sector is struggling to compete with cheaper virgin plastic imports as sky-high energy prices push up their operating costs.

Plastics recyclers are calling policy makers to introduce "effective import controls and enforcing existing legislation, including the restriction of importing materials which do not meet equivalent EU sustainability and safety standards,".

## INDUSTRY MINISTERS' WIDE-RANGING SUGGESTIONS FOR EVER GREATER "SIMPLIFICATION" OF ENVIRONMENTAL TEXTS

The Commission left the Competitiveness Council on March 12 with a long "to-do list." The Polish Presidency had asked Industry Ministers to identify other legislation that should be subject to "simplification" measures, following the first two packages at the end of February. The Czech Republic and Slovenia mentioned the Deforestation Regulation; Bulgaria, Slovakia, Austria, and Estonia discussed the Urban Wastewater Directive; Lithuania highlighted product texts (packaging, labeling, extended producer responsibility), supported by Slovakia, which added the Ecodesign Regulation to the list. Estonia and Slovakia also mentioned the Chemicals Labeling Regulation (CLP). "We take note of your suggestions, which could be candidates for the next step in the simplification agenda," responded Commissioner Dombrovskis. During this debate, all Member States welcomed the omnibus package on the duty of care (CS3D) and non-financial reporting (CSRD). Many, like France, supported the proposal to suspend their implementation while the omnibus texts are adopted and to negotiate quickly.
